ONCE A PROVIDER IS CHOSEN, AGENTS CAN SELECT THE COURSES THEY WISH TO TAKE. THEY MUST COMPLETE THE MANDATORY CORE COURSE AND THEN CHOOSE FROM ELECTIVE COURSES TO FULFILL THE REMAINING HOURS. IT'S ESSENTIAL TO VERIFY THAT THE COURSES CHOSEN ARE ELIGIBLE FOR CE CREDIT.

### COMPLETE THE COURSES

AGENTS CAN OFTEN CHOOSE TO COMPLETE THEIR COURSES EITHER ONLINE OR IN-PERSON, DEPENDING ON THEIR PREFERENCE AND THE PROVIDER'S OFFERINGS. ONLINE COURSES OFFER FLEXIBILITY, ALLOWING AGENTS TO LEARN AT THEIR OWN PACE, WHILE IN-PERSON CLASSES MAY PROVIDE A MORE INTERACTIVE EXPERIENCE.

### KEEP DOCUMENTATION

UPON COMPLETION OF THE COURSES, AGENTS SHOULD ENSURE THEY RECEIVE A CERTIFICATE OF COMPLETION FROM THE PROVIDER. THIS DOCUMENTATION IS ESSENTIAL FOR LICENSE RENEWAL AND SHOULD BE KEPT ON FILE.

### SUBMIT RENEWAL APPLICATION

ONCE THE CE REQUIREMENTS ARE FULFILLED, REAL ESTATE PROFESSIONALS MUST SUBMIT THEIR LICENSE RENEWAL APPLICATION TO THE FLORIDA DEPARTMENT OF BUSINESS AND PROFESSIONAL REGULATION (DBPR). IT'S IMPORTANT TO SUBMIT THE APPLICATION BEFORE THE LICENSE EXPIRATION DATE TO AVOID ANY PENALTIES OR FEES.

## TIPS FOR SUCCESS IN CONTINUING EDUCATION

TO MAKE THE MOST OF THE CONTINUING EDUCATION EXPERIENCE, CONSIDER THE FOLLOWING TIPS:
