THOMAS JEFFERSON'S ROLE

THOMAS JEFFERSON PLAYED A PIVOTAL ROLE IN DRAFTING THE ACT, REFLECTING HIS STRONG BELIEF IN RELIGIOUS LIBERTY AS A FUNDAMENTAL HUMAN RIGHT.
