

A MORE PERFECT UNION

A **MORE PERFECT UNION** IS A PHRASE THAT RESONATES DEEPLY WITHIN THE CONTEXT OF AMERICAN HISTORY AND DEMOCRATIC IDEALS. THIS LED TO THE DRAFTING OF THE U.S. CONSTITUTION, WHICH INCLUDED THE PREAMBLE THAT FAMOUSLY BEGINS WITH THE PHRASE “WE THE PEOPLE.”

SIGNIFICANCE OF THE PREAMBLE

THE PREAMBLE SERVES AS AN INTRODUCTION TO THE CONSTITUTION, OUTLINING ITS FUNDAMENTAL GOALS. CORE PRINCIPLES OF A MORE PERFECT UNION

1. JUSTICE
