OVERVIEW OF ALABAMA SECURITY GUARD REQUIREMENTS

TO WORK AS A SECURITY GUARD IN ALABAMA, INDIVIDUALS MUST COMPLY WITH SPECIFIC STATE REGULATIONS GOVERNING THE INDUSTRY. THESE REQUIREMENTS ARE DESIGNED TO ENSURE THAT SECURITY PERSONNEL ARE QUALIFIED, RESPONSIBLE, AND CAPABLE OF PROTECTING PEOPLE AND PROPERTY EFFECTIVELY. THE ALABAMA DEPARTMENT OF LABOR AND THE ALABAMA SECURITY REGULATORY BOARD OVERSEE THE LICENSING AND TRAINING STANDARDS FOR SECURITY GUARDS.

ELIGIBILITY CRITERIA

PROSPECTIVE SECURITY GUARDS IN ALABAMA MUST MEET SEVERAL ELIGIBILITY REQUIREMENTS BEFORE ENROLLING IN SECURITY GUARD TRAINING PROGRAMS OR APPLYING FOR A LICENSE. THESE CRITERIA INCLUDE AGE RESTRICTIONS, BACKGROUND CHECKS, AND OTHER PREREQUISITES SET BY THE STATE.

- MUST BE A U.S. CITIZEN OR LAWFUL PERMANENT RESIDENT
- MUST PASS A CRIMINAL BACKGROUND CHECK WITH NO DISQUALIFYING OFFENSES
- MUST HAVE A CLEAN RECORD REGARDING VIOLENCE OR DRUG-RELATED CRIMES

LEGAL FRAMEWORK

ALABAMA SECURITY GUARD TRAINING AND LICENSING ARE REGULATED UNDER THE ALABAMA PRIVATE INVESTIGATION AND SECURITY BOARD. THE BOARD ESTABLISHES GUIDELINES FOR TRAINING CURRICULUM, CERTIFICATION EXAMS, AND ONGOING EDUCATION REQUIREMENTS. YES, ARMED SECURITY GUARDS IN ALABAMA MUST COMPLETE ADDITIONAL FIREARMS TRAINING AND CERTIFICATION APPROVED BY THE ALABAMA SECURITY REGULATORY BOARD BEFORE CARRYING A WEAPON ON DUTY.
