- RUN: EVACUATE SAFELY IF POSSIBLE, LEAVE BELONGINGS BEHIND, AND HELP OTHERS ESCAPE.
- HIDE: FIND A SECURE LOCATION, LOCK DOORS, SILENCE PHONES, AND REMAIN QUIET.
- FIGHT: AS A LAST RESORT, TAKE AGGRESSIVE ACTION TO INCAPACITATE THE ATTACKER USING IMPROVISED WEAPONS.

## COMMUNICATION AND REPORTING PROCEDURES

EFFECTIVE COMMUNICATION DURING AN ACTIVE SHOOTER EVENT IS VITAL. THE TRAINING SHOULD COVER HOW TO REPORT SUSPICIOUS ACTIVITY, WHAT INFORMATION TO PROVIDE TO LAW ENFORCEMENT, AND HOW TO COMMUNICATE WITH COWORKERS AND EMERGENCY SERVICES DURING THE CRISIS.

## POST-INCIDENT PROTOCOLS

GUIDANCE ON WHAT TO DO AFTER THE INCIDENT IS EQUALLY IMPORTANT. THIS INCLUDES MEDICAL FIRST AID BASICS, ACCOUNTING FOR ALL PERSONNEL, COOPERATING WITH LAW ENFORCEMENT INVESTIGATIONS, AND ACCESSING SUPPORT SERVICES.

# DESIGNING AND DELIVERING THE TRAINING PRESENTATION

# AUDIENCE ENGAGEMENT TECHNIQUES

INTERACTIVE ELEMENTS LIKE QUIZZES, SCENARIO-BASED QUESTIONS, AND GROUP DISCUSSIONS CAN INCREASE PARTICIPANT INVOLVEMENT.
