ISSUERS

ISSUERS ARE ENTITIES THAT RAISE FUNDS BY OFFERING SECURITIES TO THE MARKET. THESE INCLUDE CORPORATIONS ISSUING SHARES OR BONDS, GOVERNMENTS ISSUING TREASURY SECURITIES, AND MUNICIPALITIES FINANCING PUBLIC PROJECTS. ISSUERS RELY ON CAPITAL MARKETS TO MEET FINANCING REQUIREMENTS FOR GROWTH AND DEVELOPMENT.

INTERMEDIARIES

FINANCIAL INTERMEDIARIES SUCH AS INVESTMENT BANKS, BROKERS, AND DEALERS FACILITATE TRANSACTIONS BETWEEN INVESTORS AND ISSUERS. THEY PROVIDE UNDERWRITING SERVICES, MARKET MAKING, ADVISORY, AND BROKERAGE SERVICES THAT ENHANCE MARKET ACCESSIBILITY AND EFFICIENCY.

REGULATORS
