AMERICAN ASSOCIATION OF BLOOD BANKS STANDARDS

THE AMERICAN ASSOCIATION OF BLOOD BANKS (AABB) IS A PREMIER ORGANIZATION DEDICATED TO THE ADVANCEMENT OF TRANSFUSION MEDICINE AND CELLULAR THERAPIES. ESTABLISHED IN 1957, AABB HAS DEVELOPED A COMPREHENSIVE SET OF STANDARDS THAT ENSURE THE SAFETY, QUALITY, AND EFFECTIVENESS OF BLOOD AND BLOOD PRODUCTS. - NUCLEIC ACID TESTING (NAT) FOR VIRAL PATHOGENS
- SEROLOGICAL TESTING FOR BLOOD TYPE AND INFECTIOUS DISEASES
- QUALITY CONTROL MEASURES DURING BLOOD PROCESSING

SUCH PRACTICES ENSURE THAT BLOOD PRODUCTS ARE NOT ONLY SAFE BUT ALSO EFFECTIVE IN TREATING MEDICAL CONDITIONS.

3. REGULATORY COMPLIANCE

THE AABB STANDARDS PROMOTE A CULTURE OF CONTINUOUS IMPROVEMENT WITHIN BLOOD BANKS. BY REGULARLY REVIEWING AND UPDATING STANDARDS, AABB ENCOURAGES ORGANIZATIONS TO ADOPT NEW TECHNOLOGIES AND PRACTICES THAT ENHANCE PATIENT CARE AND OPERATIONAL EFFICIENCY.

STRUCTURE OF AABB STANDARDS

AABB STANDARDS ARE ORGANIZED INTO SEVERAL CATEGORIES, EACH ADDRESSING SPECIFIC ASPECTS OF BLOOD BANKING. THE KEY SECTIONS INCLUDE:

1. GENERAL REQUIREMENTS
