Direct Quotations and Paraphrasing

APA style distinguishes between direct quotations and paraphrasing, each requiring specific citation formats. Proper citation of both is necessary to credit original ideas accurately and avoid plagiarism.

Direct Quotations

When directly quoting a source, the citation must include the author's last name, year of publication, and the page number or paragraph number for non-paginated sources. The quotation should be enclosed in quotation marks if it is fewer than 40 words, or formatted as a block quote if longer.
