

ANIMAL LIBERATION BY PETER SINGER

INTRODUCTION TO ANIMAL LIBERATION

ANIMAL LIBERATION IS A SIGNIFICANT PHILOSOPHICAL WORK BY PETER SINGER, PUBLISHED IN 1975. - **SPECIESISM:** THE BELIEF THAT HUMAN BEINGS ARE SUPERIOR TO OTHER ANIMALS AND THUS ENTITLED TO EXPLOIT THEM.
- **EQUAL CONSIDERATION:** THE IDEA THAT THE INTERESTS OF ALL BEINGS, REGARDLESS OF SPECIES, SHOULD BE CONSIDERED EQUALLY.

THE CAPACITY TO SUFFER

SINGER EMPHASIZES THAT THE CAPACITY TO SUFFER IS WHAT GRANTS MORAL STATUS TO AN ANIMAL. HE ARGUES THAT ANIMALS, LIKE HUMANS, EXPERIENCE PAIN AND DISTRESS, AND THEREFORE THEIR INTERESTS SHOULD BE TAKEN INTO ACCOUNT. THIS FOCUS ON SUFFERING AS A CRITERION FOR MORAL CONSIDERATION IS A PIVOTAL ASPECT OF SINGER'S ARGUMENTS.

IMPLICATIONS OF ANIMAL LIBERATION

ETHICAL CONSIDERATIONS

THE IMPLICATIONS OF SINGER'S ARGUMENTS EXTEND INTO VARIOUS ETHICAL CONSIDERATIONS, SUCH AS:

1. **DIETARY CHOICES:** SINGER ADVOCATES FOR VEGETARIANISM AND VEGANISM AS ETHICAL ALTERNATIVES TO CONSUMING

LEGAL AND SOCIAL CHANGE
