PRACTICE RELAXATION TECHNIQUES SUCH AS DEEP BREATHING TO HELP MANAGE ANXIETY. REMEMBER, YOU HAVE PREPARED THOROUGHLY FOR THIS MOMENT.

AFTER THE EXAM

ONCE YOU COMPLETE THE ARIZONA REAL ESTATE STATE EXAM, THE NEXT STEPS INVOLVE AWAITING YOUR RESULTS AND APPLYING FOR YOUR LICENSE.

1. EXAM RESULTS

TO RENEW YOUR LICENSE, YOU MUST SUBMIT PROOF OF COMPLETED CONTINUING EDUCATION AND PAY THE RENEWAL FEE BEFORE THE EXPIRATION DATE.
