### 5. REASON FOR REFERRAL/VISIT

HERE, PRACTITIONERS CAN DOCUMENT THE SPECIFIC ISSUES OR CONCERNS THAT LED TO THE CLIENT SEEKING ASSISTANCE. THIS MIGHT INCLUDE:

- PRESENTING PROBLEMS
- DURATION OF ISSUES
- PREVIOUS TREATMENT ATTEMPTS

### 6. GOALS AND EXPECTATIONS

UNDERSTANDING WHAT THE CLIENT HOPES TO ACHIEVE IS CRITICAL FOR SETTING EFFECTIVE TREATMENT GOALS. THIS SECTION SHOULD OUTLINE:

- CLIENT'S SHORT-TERM GOALS
- LONG-TERM ASPIRATIONS
- EXPECTATIONS FROM THE PRACTITIONER

## BEST PRACTICES FOR USING THE ASHA CASE HISTORY FORM

TO MAXIMIZE THE EFFECTIVENESS OF THE ASHA CASE HISTORY FORM, PRACTITIONERS SHOULD CONSIDER THE FOLLOWING BEST PRACTICES:

## 1. ENSURE CONFIDENTIALITY

DUE TO THE SENSITIVE NATURE OF THE INFORMATION COLLECTED IN THE ASHA CASE HISTORY FORM, IT IS IMPERATIVE TO MAINTAIN CONFIDENTIALITY. PRACTITIONERS SHOULD:

- USE SECURE STORAGE FOR PHYSICAL DOCUMENTS.

- UPDATE THE FORM FOLLOWING SIGNIFICANT CHANGES IN THE CLIENT'S SITUATION.
- USE THE UPDATED INFORMATION TO ADJUST TREATMENT PLANS ACCORDINGLY.

## 4. TRAINING FOR PRACTITIONERS
