RECOGNIZING THESE ADAPTATIONS HELPS NURSES ANTICIPATE NORMAL VERSUS PATHOLOGICAL FINDINGS DURING PRENATAL ASSESSMENTS.

ROUTINE PRENATAL ASSESSMENTS

PRENATAL CARE AIMS TO MONITOR THE HEALTH OF BOTH MOTHER AND FETUS THROUGHOUT PREGNANCY. KEY PRENATAL INTERVENTIONS

INTERVENTIONS DURING PRENATAL CARE FOCUS ON PROMOTING MATERNAL AND FETAL WELL-BEING. LABOR AND DELIVERY MANAGEMENT

STAGES OF LABOR

THE LABOR PROCESS IS DIVIDED INTO THREE STAGES: THE FIRST STAGE INVOLVES CERVICAL DILATION AND EFFACEMENT, THE SECOND STAGE IS DELIVERY OF THE BABY, AND THE THIRD STAGE IS THE EXPULSION OF THE PLACENTA. FETAL MONITORING TECHNIQUES

PHARMACOLOGIC OPTIONS INCLUDE EPIDURAL ANESTHESIA, OPIOIDS, AND NITROUS OXIDE, WHILE NON-PHARMACOLOGIC APPROACHES INVOLVE BREATHING TECHNIQUES, HYDROTHERAPY, AND MASSAGE. THE CHOICE OF PAIN MANAGEMENT DEPENDS ON MATERNAL PREFERENCE, LABOR PROGRESSION, AND CLINICAL INDICATIONS.

POSTPARTUM CARE AND COMPLICATIONS

PHYSIOLOGICAL CHANGES AFTER BIRTH
