COMMON BILLING CODES AND THEIR REIMBURSEMENT RATES

ACCURATE CODING IS ESSENTIAL FOR SECURING APPROPRIATE BCBS REIMBURSEMENT RATES IN 2023. THERAPY PROVIDERS MUST USE CURRENT PROCEDURAL TERMINOLOGY (CPT) CODES TO DESCRIBE THE SERVICES DELIVERED. EACH CODE CORRESPONDS TO A SPECIFIC REIMBURSEMENT RATE.

PHYSICAL THERAPY CODES
