- CHOOSE THE TYPES OF DATA TO DELETE, SUCH AS HISTORY, COOKIES, CACHE, AND DOWNLOAD RECORDS.
- CONFIRM THE ACTION TO ERASE THE SELECTED DATA.

USERS CAN ALSO SET BROWSERS TO CLEAR HISTORY AUTOMATICALLY UPON CLOSING OR USE INCOGNITO/PRIVATE MODE FOR SESSIONS REQUIRING NO HISTORY RETENTION.

USING PRIVATE BROWSING MODES

PRIVATE OR INCOGNITO MODES PREVENT BROWSERS FROM SAVING HISTORY, COOKIES, OR FORM DATA DURING THE SESSION.

WHILE THIS ENHANCES PRIVACY ON THE USER'S DEVICE, IT DOES NOT GUARANTEE ANONYMITY FROM INTERNET SERVICE PROVIDERS, NETWORK ADMINISTRATORS, OR VISITED WEBSITES.

TECHNOLOGICAL TOOLS FOR PROTECTING ONLINE PRIVACY

BEYOND MANUAL HISTORY MANAGEMENT, VARIOUS TECHNOLOGICAL SOLUTIONS HELP SAFEGUARD ONLINE PRIVACY, ESPECIALLY WHEN BROWSING SENSITIVE CONTENT SUCH AS ADULT WEBSITES.

VIRTUAL PRIVATE NETWORKS (VPNS)

PRIVACY-FOCUSED BROWSERS AND EXTENSIONS

BROWSERS LIKE TOR OR BRAVE EMPHASIZE ANONYMITY AND PRIVACY, REDUCING DATA TRACKING. ADDITIONALLY, BROWSER EXTENSIONS CAN BLOCK TRACKERS, ADS, AND MALICIOUS SCRIPTS THAT MAY COLLECT BROWSING INFORMATION.

ENCRYPTED STORAGE AND PASSWORD PROTECTION

ENCRYPTING DEVICE STORAGE AND USING STRONG PASSWORDS PREVENT UNAUTHORIZED ACCESS TO BROWSING DATA STORED LOCALLY. BIOMETRIC AUTHENTICATION AND SECURE USER ACCOUNTS FURTHER ENHANCE PROTECTION.

CULTURAL AND PSYCHOLOGICAL ASPECTS OF ADULT CONTENT BROWSING
