- FINANCIAL MANAGEMENT
- INFORMATION TECHNOLOGY

### 3. FINANCIAL ACCOUNTING AND REPORTING (FAR)

FAR IS OFTEN CONSIDERED THE MOST CHALLENGING SECTION DUE TO ITS EXTENSIVE CONTENT. IT INCLUDES:

- FINANCIAL STATEMENTS AND REPORTING
- TRANSACTIONS AND EVENTS
- ACCOUNTING STANDARDS
- GOVERNMENTAL AND NOT-FOR-PROFIT ACCOUNTING

### 4. REGULATION (REG)

REG COVERS THE LEGAL ASPECTS AND REGULATIONS IMPACTING THE ACCOUNTING PROFESSION. IMPORTANT AREAS INCLUDE:

- ETHICS AND PROFESSIONAL RESPONSIBILITIES
- BUSINESS LAW
- FEDERAL TAXATION

## FACTORS INFLUENCING THE ORDER OF CPA EXAMS

### 2. CONTENT OVERLAP

SOME SECTIONS HAVE OVERLAPPING CONTENT, AND TAKING THEM IN A PARTICULAR ORDER CAN HELP REINFORCE YOUR KNOWLEDGE. FOR INSTANCE:

- BEC PROVIDES FOUNDATIONAL KNOWLEDGE THAT CAN BE USEFUL FOR FAR.
- FAR INCLUDES TOPICS RELEVANT TO REG, PARTICULARLY REGARDING CORPORATE TAXATION.

### 3. SCHEDULING AND TIME MANAGEMENT

CONSIDER YOUR AVAILABILITY AND STUDY SCHEDULE. IF YOU HAVE A BUSY PERIOD APPROACHING, YOU MIGHT WANT TO TAKE A LESS INTENSIVE SECTION FIRST. ALSO, EACH SECTION REQUIRES A DIFFERENT AMOUNT OF STUDY TIME:

- AUD: APPROXIMATELY 200-300 HOURS
- BEC: APPROXIMATELY 150-250 HOURS
- FAR: APPROXIMATELY 300-400 HOURS
- REG: APPROXIMATELY 200-300 HOURS

## POPULAR CPA EXAM ORDER RECOMMENDATIONS

- AUD: FOLLOW UP WITH AUD, WHICH BUILDS ON SOME FAR CONCEPTS.
- REG: NEXT, TACKLE REG, AS IT OFTEN FEELS MORE MANAGEABLE AFTER THE PREVIOUS TWO.
- BEC: FINALLY, END WITH BEC, WHICH MANY FIND LESS INTENSIVE AND MORE STRAIGHTFORWARD.

## 2. BEC → FAR → AUD → REG

AN ALTERNATIVE RECOMMENDATION IS TO START WITH BEC TO BUILD CONFIDENCE BEFORE FACING THE TOUGHER SECTIONS:

- BEC: EASES YOU INTO THE EXAM FORMAT AND HELPS FAMILIARIZE YOU WITH EXAM STRATEGIES.
- FAR: NEXT, TAKE ON THE HEAVY CONTENT OF FAR WHILE THE CONCEPTS FROM BEC ARE STILL FRESH.
- AUD: MOVE TO AUD, WHICH HAS SOME OVERLAP WITH FAR.
- REG: FINISH WITH REG, WHICH CAN BE LESS OVERWHELMING AFTER THE PRIOR SECTIONS.

## 3. AUD → REG → FAR → BEC

SOME CANDIDATES PREFER TO TACKLE AUDITING FIRST DUE TO THEIR FAMILIARITY WITH IT:

- AUD: STARTING WITH AUD CAN GIVE A SOLID GROUNDING IN THE AUDIT PROCESS.
- REG: PROCEED TO REG, WHICH ALSO RELIES ON CONCEPTS FROM AUD.
- FAR: FOLLOW UP WITH FAR, WHICH CAN BE EASIER AFTER UNDERSTANDING THE REGULATORY ENVIRONMENT.
- BEC: CONCLUDE WITH BEC, ALLOWING FOR A LIGHTER FINAL EXAM.

# TIPS FOR PREPARING FOR THE CPA EXAMS

REGARDLESS OF THE ORDER YOU CHOOSE, EFFECTIVE PREPARATION IS KEY TO SUCCESS. HERE ARE SOME TIPS TO ENHANCE YOUR STUDY EFFORTS:

## 1. CREATE A STUDY SCHEDULE

### IS IT BETTER TO TAKE CPA EXAMS BACK-TO-BACK OR SPREAD THEM OUT?

MANY REDDITORS ADVISE SPREADING THE EXAMS OUT TO ALLOW TIME FOR STUDYING AND RETAINING INFORMATION. HOWEVER, IF YOU CAN HANDLE THE PRESSURE, SOME CANDIDATES CHOOSE TO TAKE THEM BACK-TO-BACK TO STAY IN 'EXAM MODE' AND MAINTAIN MOMENTUM.

### WHAT ARE COMMON PITFALLS TO AVOID WHEN PLANNING THE ORDER OF CPA EXAMS?

COMMON PITFALLS INCLUDE UNDERESTIMATING THE TIME REQUIRED TO STUDY FOR EACH SECTION, NOT CONSIDERING PERSONAL

STUDY HABITS, AND FAILING TO ACCOUNT FOR THE EXAM SCHEDULE AND ANY PERSONAL COMMITMENTS. AVOID RUSHING INTO THE NEXT EXAM WITHOUT ADEQUATE PREPARATION.

## **HOW DO STUDY MATERIALS INFLUENCE THE ORDER IN WHICH I SHOULD TAKE CPA EXAMS?**

STUDY MATERIALS AND THEIR AVAILABILITY CAN GREATLY INFLUENCE YOUR ORDER. IF YOU HAVE ACCESS TO COMPREHENSIVE MATERIALS FOR A PARTICULAR EXAM, IT MAY BE ADVANTAGEOUS TO TAKE THAT EXAM FIRST. ADDITIONALLY, SOME MATERIALS MAY ALIGN BETTER WITH YOUR CURRENT KNOWLEDGE BASE.
