

# BROWN VS BOARD OF EDUCATION WORKSHEET

**BROWN VS BOARD OF EDUCATION WORKSHEET** SERVES AS AN ESSENTIAL EDUCATIONAL TOOL DESIGNED TO HELP STUDENTS UNDERSTAND THE HISTORIC SUPREME COURT CASE *BROWN V. BOARD OF EDUCATION*. ## OVERVIEW OF *BROWN V. BOARD OF EDUCATION*

UNDERSTANDING THE HISTORICAL AND LEGAL CONTEXT OF *BROWN V. BOARD OF EDUCATION* IS CRUCIAL FOR GRASPING THE SIGNIFICANCE OF THE *BROWN VS BOARD OF EDUCATION WORKSHEET*. THIS 1954 SUPREME COURT CASE OVERTURNED THE 1896 *PLESSY V. FERGUSON* RULING THAT HAD ESTABLISHED THE "SEPARATE BUT EQUAL" DOCTRINE. BY DECLARING THAT STATE LAWS ESTABLISHING SEPARATE PUBLIC SCHOOLS FOR BLACK AND WHITE STUDENTS WERE INHERENTLY UNEQUAL, THE COURT MANDATED THE DESEGREGATION OF SCHOOLS ACROSS AMERICA. THE CASE WAS A CONSOLIDATION OF FIVE DIFFERENT CASES CHALLENGING SEGREGATION, WITH OLIVER BROWN AS THE LEAD PLAINTIFF. THE UNANIMOUS DECISION AUTHORED BY CHIEF JUSTICE EARL WARREN MARKED A CRITICAL VICTORY FOR THE CIVIL RIGHTS MOVEMENT, SETTING A PRECEDENT FOR FUTURE ANTI-DISCRIMINATION RULINGS.

## HISTORICAL BACKGROUND

BEFORE THE *BROWN* DECISION, RACIAL SEGREGATION WAS LEGALLY SANCTIONED IN MANY STATES, PARTICULARLY IN THE SOUTHERN UNITED STATES. AFRICAN AMERICAN STUDENTS WERE REQUIRED TO ATTEND SEPARATE SCHOOLS THAT WERE OFTEN UNDERFUNDED AND INFERIOR IN QUALITY COMPARED TO SCHOOLS FOR WHITE STUDENTS. THE SOCIAL AND LEGAL CHALLENGES FACED BY BLACK FAMILIES SEEKING EQUAL EDUCATION PAVED THE WAY FOR THE CASE. THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF COLORED PEOPLE (NAACP) PLAYED A PIVOTAL ROLE IN ORGANIZING THE LEGAL BATTLE AGAINST SEGREGATION.

## LEGAL SIGNIFICANCE

THE SUPREME COURT'S RULING IN *BROWN V. BOARD OF EDUCATION* EMPHASIZED THAT SEGREGATION VIOLATED THE EQUAL PROTECTION CLAUSE OF THE FOURTEENTH AMENDMENT. THIS RULING REJECTED THE NOTION THAT SEPARATE FACILITIES COULD EVER BE TRULY EQUAL, FUNDAMENTALLY REDEFINING CONSTITUTIONAL PROTECTIONS AGAINST RACIAL DISCRIMINATION IN

EDUCATION. IT CATALYZED LEGISLATIVE AND SOCIAL CHANGES, INFLUENCING CIVIL RIGHTS POLICIES NATIONWIDE.

## PURPOSE AND BENEFITS OF THE WORKSHEET

# INTEGRATING THE WORKSHEET INTO CURRICULUM
