THE BACKGROUND OF THE EXCISE TAX

1. **ECONOMIC BURDEN:** AFTER THE FRENCH AND INDIAN WAR, BRITAIN FACED A SIGNIFICANT DEBT AND SOUGHT TO RECOUP SOME LOSSES THROUGH TAXATION. THIS LED TO SEVERAL ACTS, INCLUDING THE SUGAR ACT AND THE STAMP ACT, WHICH WERE MET WITH RESISTANCE FROM COLONISTS.
2. **THE TOWNSHEND ACTS:** IN 1767, THE TOWNSHEND ACTS WERE ENACTED, IMPOSING DUTIES ON IMPORTED GOODS SUCH AS GLASS, PAPER, PAINT, AND TEA. THESE ACTS HEIGHTENED TENSIONS BETWEEN BRITAIN AND THE COLONIES, PARTICULARLY IN BOSTON, A HUB OF REBELLION.

BOSTONIANS' RESPONSE TO THE EXCISE TAX

FORMS OF RESISTANCE
