

# BOEING ACCUSED OF STEALING TECHNOLOGY

## ORIGINS OF THE ACCUSATIONS

THE CORE OF THESE ACCUSATIONS CENTERS ON THE UNAUTHORIZED USE OF PROPRIETARY TECHNOLOGY, WHICH IF PROVEN, COULD VIOLATE TRADE SECRET LAWS AND LEAD TO SUBSTANTIAL PENALTIES.

## KEY TECHNOLOGIES AT THE CENTER OF ALLEGATIONS

SEVERAL AREAS OF TECHNOLOGY HAVE BEEN HIGHLIGHTED IN ACCUSATIONS AGAINST BOEING, INCLUDING:

## GOVERNMENT INVESTIGATIONS AND COMPLIANCE REVIEWS

REGULATORY BODIES HAVE CONDUCTED INVESTIGATIONS INTO BOEING'S CORPORATE PRACTICES FOLLOWING ALLEGATIONS OF TECHNOLOGY THEFT.
