

BURNING A ANSWER KEY

ULTIMATELY, FOSTERING A CULTURE OF HONESTY AND ACCOUNTABILITY WITHIN EDUCATIONAL SETTINGS IS PARAMOUNT, AND THE METHODS EMPLOYED TO ACHIEVE THIS GOAL SHOULD REFLECT A COMMITMENT TO THESE VALUES.
