AWAITING RESULTS

1. **LICENSURE APPLICATION:** COMPLETE THE NECESSARY STEPS TO APPLY FOR LICENSURE IN CALIFORNIA.
2. **CONTINUING EDUCATION:** STAY UPDATED WITH CONTINUING EDUCATION REQUIREMENTS TO MAINTAIN YOUR LICENSE.

IF YOU DO NOT PASS

- **REVIEW PERFORMANCE:** ANALYZE YOUR SCORE REPORT TO IDENTIFY WEAK AREAS.
- **RETAKE OPTIONS:** RESEARCH THE PROCESS FOR RETAKING THE EXAMINATION, INCLUDING WAITING PERIODS AND ADDITIONAL PREPARATION RESOURCES.
