- DISCLOSURE REQUIREMENTS: BE AWARE OF MANDATORY DISCLOSURES, INCLUDING MATERIAL FACTS AND ENVIRONMENTAL HAZARDS.
- FINANCING OPTIONS: STUDY THE DIFFERENT FINANCING METHODS AVAILABLE TO BUYERS AND SELLERS, INCLUDING CONVENTIONAL LOANS, FHA LOANS, AND VA LOANS.

CALIFORNIA REAL ESTATE LAW

- **REAL ESTATE LICENSE LAW:** FAMILIARIZE YOURSELF WITH THE REGULATIONS GOVERNING REAL ESTATE LICENSES IN CALIFORNIA, INCLUDING RENEWAL REQUIREMENTS AND DISCIPLINARY ACTIONS.
- **TRUST FUNDS:** UNDERSTAND THE HANDLING AND ACCOUNTING OF TRUST FUNDS, INCLUDING THE OBLIGATIONS OF AGENTS TO MANAGE CLIENT FUNDS.
