UNDERSTANDING THE RACIAL CONTRACT

DEFINITION AND NATURE OF THE RACIAL CONTRACT

AT ITS CORE, THE RACIAL CONTRACT ASSERTS THAT WHITE SUPREMACY IS INSTITUTIONALIZED THROUGH A SET OF NORMATIVE AGREEMENTS. IT IS A PERVERSIVE, SYSTEMIC STRUCTURE RATHER THAN AN ISOLATED ACT OF DISCRIMINATION.

HOW THE RACIAL CONTRACT OPERATES

THE OPERATION OF THE RACIAL CONTRACT IS OFTEN INVISIBLE TO THOSE WHO BENEFIT FROM IT, ESPECIALLY WHITE INDIVIDUALS, MAKING IT A HIDDEN YET POWERFUL MECHANISM OF RACIAL OPPRESSION. IT MANIFESTS IN SOCIAL PRACTICES, LEGAL SYSTEMS, AND ECONOMIC ARRANGEMENTS THAT FAVOR WHITENESS. THE CONTRACT ALSO SHAPES CULTURAL NARRATIVES AND IDEOLOGIES THAT JUSTIFY AND NORMALIZE RACIAL INEQUALITIES.

HISTORICAL AND PHILOSOPHICAL CONTEXT

CHARLES MILLS' RACIAL CONTRACT THEORY EMERGES AS A CRITICAL RESPONSE TO THE DOMINANT WESTERN POLITICAL PHILOSOPHY TRADITION. EXCLUSION OF NON-WHITE PEOPLES IN SOCIAL CONTRACTS

MILLS POINTS OUT THAT MANY CLASSICAL SOCIAL CONTRACT THEORISTS EXPLICITLY OR IMPLICITLY EXCLUDED NON-WHITE POPULATIONS FROM THE CATEGORY OF FULL POLITICAL SUBJECTS. THIS EXCLUSION LEGITIMIZED COLONIALISM, SLAVERY, AND RACIAL SEGREGATION BY DENYING NON-WHITE COMMUNITIES THE PROTECTIONS AND RIGHTS GRANTED UNDER THE SOCIAL CONTRACT. THE RACIAL CONTRACT THEORY HIGHLIGHTS THIS FOUNDATIONAL RACIAL EXCLUSION AS A CENTRAL FLAW IN TRADITIONAL POLITICAL PHILOSOPHY.

KEY THEMES IN CHARLES MILLS' WORK

THE CONCEPT OF RACIAL EPISTEMOLOGY

THE THEORY INTRODUCES THE IDEA OF RACIAL EPISTEMOLOGY, WHICH EXAMINES HOW KNOWLEDGE PRODUCTION IS INFLUENCED BY RACIAL BIASES.
