- RANDOM INSPECTIONS: UNANNOUNCED INSPECTIONS OF TESTING FACILITIES TO EVALUATE COMPLIANCE.
- DOCUMENTATION REVIEW: REVIEWING PAPERWORK AND SCORING SHEETS TO ENSURE ACCURACY AND COMPLETENESS.

CONSEQUENCES OF NON-COMPLIANCE

WHAT DOCUMENTATION IS REQUIRED FOR CANDIDATES TAKING A CDL SKILLS TEST WITH A THIRD-PARTY EXAMINER?

CANDIDATES MUST PROVIDE VALID IDENTIFICATION, PROOF OF RESIDENCY, A COMPLETED APPLICATION FOR A CDL, AND ANY NECESSARY MEDICAL CERTIFICATION DOCUMENTS BEFORE TAKING THE SKILLS TEST WITH A THIRD-PARTY EXAMINER.

ARE THERE SPECIFIC ASSESSMENT CRITERIA OUTLINED IN THE CDL THIRD PARTY EXAMINER MANUAL?
