- A COMPANY RECEIVES A DATA BREACH REPORT. WHAT IS THE FIRST STEP THEY SHOULD TAKE?
 1. NOTIFY AFFECTED INDIVIDUALS
 2. ASSESS THE BREACH'S IMPACT
 3. REPORT TO LAW ENFORCEMENT
 4. UPDATE THEIR PRIVACY POLICY

TRUE/FALSE QUESTIONS

THESE QUESTIONS ASSESS YOUR UNDERSTANDING OF SPECIFIC PRIVACY LAWS AND PRINCIPLES. FOR EXAMPLE:

- THE CCPA ALLOWS CONSUMERS TO REQUEST THE DELETION OF THEIR PERSONAL INFORMATION. (TRUE/FALSE)

STRATEGIES FOR EFFECTIVE PREPARATION
