THE RENEWAL PROCESS

RENEWING YOUR BUSINESS LICENSE IN CLARK COUNTY INVOLVES A STRAIGHTFORWARD PROCESS. BELOW ARE THE STEPS YOU NEED TO FOLLOW:

STEP 1: GATHER NECESSARY INFORMATION

BEFORE STARTING THE RENEWAL PROCESS, ENSURE YOU HAVE THE FOLLOWING INFORMATION HANDY:

- BY MAIL: IF YOU PREFER TRADITIONAL METHODS, YOU CAN DOWNLOAD AND PRINT THE RENEWAL FORM, FILL IT OUT, AND SEND IT TO THE BUSINESS LICENSE OFFICE.
- IN-PERSON: ALTERNATIVELY, VISIT THE BUSINESS LICENSE OFFICE TO SUBMIT YOUR RENEWAL APPLICATION DIRECTLY.

STEP 3: PAY THE RENEWAL FEE
