- “TRUE OR FALSE: THE PRIMARY ROLE OF A CONSULTANT IS TO PRESENT SOLUTIONS WITHOUT ENGAGING WITH THE CLIENT’S TEAM.”

4. SHORT ANSWER QUESTIONS

WHILE LESS COMMON IN PRACTICE QUESTIONS, SOME MATERIALS MAY INCLUDE SHORT ANSWER QUESTIONS THAT REQUIRE YOU TO EXPLAIN CONCEPTS OR METHODOLOGIES IN YOUR OWN WORDS.

EFFECTIVE STRATEGIES FOR USING CMC PRACTICE QUESTIONS

6. TAKE CARE OF YOUR HEALTH

- ENSURE YOU MAINTAIN A HEALTHY STUDY-LIFE BALANCE. PROPER REST, NUTRITION, AND EXERCISE CAN SIGNIFICANTLY IMPACT

YOUR COGNITIVE FUNCTION AND RETENTION CAPABILITIES.
