- GIVEN A SPECIFIC SITUATION, DETERMINE WHETHER THE DATA PROCESSING ACTIVITIES ARE COMPLIANT WITH THE HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT (HIPAA).

3. ANALYSIS QUESTIONS

THESE QUESTIONS REQUIRE A DEEPER LEVEL OF CRITICAL THINKING, WHERE YOU MUST ANALYZE A SITUATION AND MAKE RECOMMENDATIONS BASED ON YOUR KNOWLEDGE. FOR EXAMPLE:

- ANALYZE A COMPANY'S PRIVACY POLICY AND IDENTIFY POTENTIAL AREAS OF NON-COMPLIANCE WITH THE GENERAL DATA PROTECTION REGULATION (GDPR) AS IT PERTAINS TO U.S. OPERATIONS.
- EVALUATE A DATA BREACH INCIDENT AND RECOMMEND STEPS FOR MITIGATING FUTURE RISKS BASED ON EXISTING REGULATIONS.

EFFECTIVE STUDY STRATEGIES FOR THE CIPP/US EXAM
