UNDERSTANDING CHILDHOOD IN A GLOBAL CONTEXT

THIS BROAD OUTLOOK ENCOURAGES A MORE INCLUSIVE AND EMPATHETIC UNDERSTANDING OF CHILDREN'S LIVES WORLDWIDE.

DEFINING CHILDHOOD ACROSS CULTURES

THE DEFINITION OF CHILDHOOD VARIES IMMENSELY DEPENDING ON CULTURAL, SOCIAL, AND ECONOMIC CONTEXTS. IN SOME SOCIETIES, CHILDHOOD MAY BE A RELATIVELY SHORT PERIOD, WITH CHILDREN TAKING ON ADULT RESPONSIBILITIES EARLY, WHILE IN OTHERS, CHILDHOOD CAN BE PROLONGED WITH EXTENDED EDUCATION AND CARE. DAILY LIFE AND PLAY

DAILY ACTIVITIES AND PLAY ARE CRITICAL COMPONENTS OF CHILDHOOD AND DIFFER MARKEDLY WORLDWIDE. SOCIAL AND ECONOMIC FACTORS INFLUENCING CHILDHOOD
