

# CNA SCOPE OF PRACTICE FLORIDA

- COMMUNICATING EFFECTIVELY WITH PATIENTS AND THEIR FAMILIES, AS WELL AS WITH OTHER HEALTHCARE TEAM MEMBERS.
- DOCUMENTING PATIENT CARE AND REPORTING ANY CHANGES IN A PATIENT'S CONDITION TO NURSING STAFF.

## LEGAL FRAMEWORK GOVERNING CNA PRACTICE IN FLORIDA

THE SCOPE OF PRACTICE FOR CNAs IN FLORIDA IS DEFINED BY STATE LAWS AND REGULATIONS. UNDERSTANDING THESE REGULATIONS IS ESSENTIAL FOR CNAs TO AVOID PRACTICING OUTSIDE THEIR LEGAL BOUNDARIES, WHICH CAN LEAD TO LEGAL REPERCUSSIONS AND JEOPARDIZE PATIENT SAFETY.

1. FLORIDA STATUTES, CHAPTER 464 - THIS CHAPTER OUTLINES THE PRACTICE OF NURSING AND THE REGULATIONS SURROUNDING NURSING ASSISTANTS IN FLORIDA.
2. RULE 64B9-15.002 - THIS RULE DEFINES THE SCOPE OF PRACTICE FOR NURSING ASSISTANTS, DETAILING THE TASKS THAT CNAs ARE PERMITTED TO PERFORM.
3. LICENSING REQUIREMENTS - CNAs MUST COMPLETE A STATE-APPROVED TRAINING PROGRAM AND PASS A COMPETENCY

EXAMINATION TO BE LICENSED IN FLORIDA.

## CNA SCOPE OF PRACTICE IN FLORIDA

THE SCOPE OF PRACTICE FOR CNAs IN FLORIDA IS CLEARLY DELINEATED TO ENSURE THAT THEY PROVIDE APPROPRIATE CARE WHILE NOT ENGAGING IN TASKS THAT REQUIRE HIGHER LEVELS OF TRAINING AND EXPERTISE.

### PERMITTED TASKS

CNAs IN FLORIDA ARE AUTHORIZED TO PERFORM A VARIETY OF TASKS, WHICH INCLUDE BUT ARE NOT LIMITED TO:

1. ASSISTING WITH PERSONAL HYGIENE AND GROOMING.
2. HELPING PATIENTS WITH MOBILITY, INCLUDING WALKING, USING A WHEELCHAIR, AND TRANSFERRING TO AND FROM BEDS OR CHAIRS.
3. FEEDING PATIENTS WHO REQUIRE ASSISTANCE.
4. CHANGING BED LINENS AND MAINTAINING A CLEAN ENVIRONMENT.
5. ASSISTING WITH BASIC MEDICAL PROCEDURES, SUCH AS TAKING VITAL SIGNS AND RECORDING PATIENT INFORMATION.
6. PROVIDING COMFORT MEASURES AND EMOTIONAL SUPPORT.

### LIMITATIONS OF CNA PRACTICE

WHILE CNAs PLAY A VITAL ROLE IN PATIENT CARE, THERE ARE SPECIFIC TASKS THAT THEY ARE NOT PERMITTED TO PERFORM, WHICH INCLUDE:

- ADMINISTERING MEDICATIONS.
- PERFORMING STERILE PROCEDURES OR WOUND CARE.
- CONDUCTING ASSESSMENTS OR DEVELOPING CARE PLANS.
- INSERTING CATHETERS OR PERFORMING OTHER INVASIVE PROCEDURES.
- PROVIDING CARE TO PATIENTS WITH COMPLEX MEDICAL NEEDS WITHOUT SUPERVISION.

IT IS CRUCIAL FOR CNAs TO UNDERSTAND THESE LIMITATIONS TO ENSURE THEY DO NOT OVERSTEP THEIR BOUNDARIES AND COMPROMISE PATIENT SAFETY.

### IMPORTANCE OF ADHERING TO THE CNA SCOPE OF PRACTICE

ADHERING TO THE DEFINED SCOPE OF PRACTICE IS ESSENTIAL FOR SEVERAL REASONS:

## PATIENT SAFETY

THE PRIMARY CONCERN OF ANY HEALTHCARE PROFESSIONAL IS THE SAFETY AND WELL-BEING OF PATIENTS. BY UNDERSTANDING AND WORKING WITHIN THEIR SCOPE OF PRACTICE, CNAS HELP PREVENT ERRORS THAT COULD LEAD TO PATIENT HARM.

## LEGAL PROTECTION

WHEN CNAS ADHERE TO THEIR SCOPE OF PRACTICE, THEY PROTECT THEMSELVES FROM LEGAL REPERCUSSIONS. PRACTICING OUTSIDE OF THE DEFINED BOUNDARIES COULD LEAD TO CHARGES OF NEGLIGENCE OR MALPRACTICE.

## PROFESSIONALISM AND ETHICAL STANDARDS

STAYING WITHIN THE CNA SCOPE OF PRACTICE PROMOTES PROFESSIONALISM AND REINFORCES THE ETHICAL STANDARDS OF THE NURSING PROFESSION. IT FOSTERS TRUST BETWEEN PATIENTS, THEIR FAMILIES, AND HEALTHCARE PROVIDERS.

## CONTINUING EDUCATION AND TRAINING

TO MAINTAIN THEIR COMPETENCY AND STAY UPDATED ON BEST PRACTICES, CNAS IN FLORIDA ARE ENCOURAGED TO ENGAGE IN CONTINUING EDUCATION AND TRAINING. THIS CAN INCLUDE:

- PARTICIPATING IN WORKSHOPS AND SEMINARS RELATED TO PATIENT CARE AND SAFETY.
- STAYING INFORMED ABOUT CHANGES IN REGULATIONS AND BEST PRACTICES.
- COMPLETING ADDITIONAL CERTIFICATIONS IN SPECIALIZED AREAS OF CARE, SUCH AS GERIATRIC CARE OR REHABILITATION.

IN FLORIDA, A CERTIFIED NURSING ASSISTANT (CNA) IS AUTHORIZED TO PERFORM BASIC PATIENT CARE TASKS, INCLUDING ASSISTING WITH ACTIVITIES OF DAILY LIVING (ADLS), PROVIDING BASIC NURSING CARE UNDER THE SUPERVISION OF A LICENSED

NO, CNAS IN FLORIDA ARE NOT PERMITTED TO ADMINISTER MEDICATIONS. THIS TASK IS RESERVED FOR LICENSED NURSES AND HEALTHCARE PROVIDERS WHO HAVE RECEIVED THE APPROPRIATE TRAINING.

## **WHAT TRAINING IS REQUIRED TO BECOME A CNA IN FLORIDA?**

TO BECOME A CNA IN FLORIDA, INDIVIDUALS MUST COMPLETE A STATE-APPROVED TRAINING PROGRAM, WHICH INCLUDES AT LEAST 120 HOURS OF INSTRUCTION AND CLINICAL PRACTICE, AND PASS THE FLORIDA CNA COMPETENCY EXAMINATION.
