PARENTS OR ATTORNEYS MAY REQUEST DEVIATIONS BY PROVIDING EVIDENCE AND JUSTIFICATION TO THE COURT. THE JUDGE WILL CONSIDER WHETHER THE DEVIATION SERVES THE BEST INTERESTS OF THE CHILD AND WHETHER IT IS EQUITABLE FOR BOTH PARTIES.

IMPACT OF DEVIATIONS

APPROVED DEVIATIONS RESULT IN ADJUSTED CHILD SUPPORT AMOUNTS THAT MAY BE HIGHER OR LOWER THAN THE GUIDELINE CALCULATION. THESE ADJUSTMENTS ENSURE THAT THE SUPPORT ORDER IS FAIR AND APPROPRIATE BASED ON THE FAMILY'S UNIQUE CIRCUMSTANCES.
