TRAINING IN DEFENSIVE TACTICS, CRISIS INTERVENTION, AND MENTAL HEALTH AWARENESS CONTRIBUTES TO OFFICER SAFETY. KNOWLEDGEABLE OFFICERS ARE MORE PREPARED TO HANDLE HIGH-STRESS SITUATIONS, REDUCING THE LIKELIHOOD OF INJURY TO THEMSELVES OR OTHERS.

5. PERSONAL GROWTH AND DEVELOPMENT

BEYOND PROFESSIONAL DEVELOPMENT, TRAINING OPPORTUNITIES PROVIDE OFFICERS WITH PERSONAL GROWTH. SKILLS LEARNED DURING TRAINING CAN TRANSLATE TO IMPROVED DECISION-MAKING AND INTERPERSONAL SKILLS IN THEIR PERSONAL LIVES.

CHALLENGES AND CONSIDERATIONS
