- STUDY GROUPS: JOIN OR FORM STUDY GROUPS TO STAY ACCOUNTABLE AND GAIN NEW INSIGHTS.
- PROFESSIONAL HELP: IF NECESSARY, CONSIDER HIRING A TUTOR OR ENROLLING IN A CPA REVIEW COURSE FOR ADDITIONAL GUIDANCE.
