FOR ELECTRONIC SOURCES, ADDITIONAL ELEMENTS SUCH AS URLS OR DOIs MAY BE INCLUDED, BUT THIS DEPENDS ON THE SOURCE TYPE.

IN-TEXT CITATION BASICS

IN APA STYLE, IN-TEXT CITATIONS TYPICALLY INCLUDE THE AUTHOR'S LAST NAME AND THE PUBLICATION YEAR. FOR EXAMPLE: (AUTHOR, YEAR). WHEN CITING THE DAVIS DRUG GUIDE 18TH EDITION, THE IN-TEXT CITATION WILL DEPEND ON HOW THE SOURCE IS REFERENCED IN THE REFERENCE LIST.

IF THE GUIDE IS ACCESSED ONLINE OR VIA AN ELECTRONIC DATABASE, THE CITATION SHOULD INCLUDE THE DOI OR URL, IF AVAILABLE, FOLLOWING THE PUBLISHER INFORMATION. THE FORMAT IS:

1. AUTHOR(S). (YEAR). *TITLE OF BOOK* (EDITION). PUBLISHER. URL OR DOI

EXAMPLE:

NOTE THAT IF THERE IS NO DOI OR STABLE URL, IT IS ACCEPTABLE TO OMIT THIS ELEMENT IN APA 7TH EDITION.

COMMON CITATION VARIATIONS AND EXAMPLES
